#### **CONTEXT**


Since 2011, the UN Guiding Principles for Business and Human Rights and the OECD Due Diligence Guidelines offered crucial frameworks for companies in the implementation of responsible business practices. Fast forward to 2019, the von der Leyen Commission doubled down on the regulatory requirements with the European Green Deal, driving up stakeholders' expectations on the effective implementation of environmental and human rights due diligence throughout the value chain.

However, the true challenge, as highlighted by CSR Europe in the reflection paper "For a Coherent and Integrated EU Approach to Due Diligence" - lies in going beyond compliance to develop supply chains that have a positive impact on the environment and the communities around them.
