[Business Uniting Talents 2030](#), the Belgian pilot project launched by CSR Europe in collaboration with the King Baudouin Foundation and the Prince Philippe Fund in 2020, built a framework to support companies in the advancement towards Ethnic Diversity and Inclusion (D&I).
