

# How to make an EU mandatory due diligence work? Webinar 8 July 2020, 14:00-15:30 CEST

#### Context

EU Commissioner for Justice Didier Reynders sent the clear signal that mandatory due diligence for companies is to be regulated at EU level. He <u>called for</u> new EU legislation on human rights and environmental due diligence throughout supply chains. The Commissioner said that corporate decision-making needs to promote sustainable business models and increase corporate accountability for human and environmental harm. He placed a special attention on company directors' responsibility for "duty of care".

With this webinar CSR Europe brings together different sector supply chain initiatives, industry federations and companies to explore how such a legislation could support the efforts towards sustainable supply chains and support the creation of positive impacts all along the supply chain. The focus of the webinar is to look from a practitioner's perspective towards the added value of a mandatory due diligence law.

#### Some suggestions could be:

- A more coherent and integrated EU approach, including smart mix of accompanying measures like bilateral agreements, aligned public procurement practices, changes in the competition law,
- European Sector Dialogues & Alliances and capacity building in local eco-systems as means to stimulate proactive engagement and practical solutions, adding a "duty to collaborate" to the "duty to care".
